We respect and value the privacy of everyone who visits this website, [www.rowtoncastle.com](http://www.rowtoncastle.com) and will only collect and use personal data in ways that are described here, and in a manner that is consistent with our obligations and your rights under the law.

We will restrict access to your data by ensuring it is always kept secure and password protected, with restricted access to paper records

#### do we share your data?

We will never share your data for third party marketing

Our website is developed and hosted by Gloversure, who store basic server access logs for debugging, security and service review (never for marketing purposes)

Our booking module is hosted by Guestline, who store information via their Rezlynx platform. Your personal data is held by them purely for the purpose of administering your booking with us (never for marketing purposes)

We may sometimes use third party data processors that are located outside of the European Economic Area (“the EEA”) (The EEA consists of all EU member states, plus Norway, Iceland, and Liechtenstein). Where we transfer any personal data outside the EEA, we will take all reasonable steps to ensure that your data is treated as safely and securely as it would be within the UK and under the GDPR including:

- Secure Trading – Online Secure Payment Experts
- Mailchimp – Email Marketing Platform
- Google Analytics – Analyse trends and website usage

In certain circumstances, we may be legally required to share certain data held by us, which may include your personal data, for example, where we are involved in legal proceedings, where we are complying with legal requirements, a court order, or a governmental authority

### our use of cookies

This website contains "cookies", which are used to optimise the efficiency of the Site for the user.
